

Mr Owens,

Officer Ferguson came by today with another officer whose name I can't recall. He was very tall and very dark-skinned, and seemed to be the man in control. Maybe his "rank" was higher than Mr. Ferguson, I don't know.

They stated they came because of a complaint made to the Governor of the Cayman Islands by my soon to be ex-wife, Elsie. She stated I was harassing her. I acknowledged this complaint, but I can also say, in my opinion, that I was able to negate it with documentation. I immediately went into my house and had Diane give me all the copies of the emails that had transpired between Elsie and me concerning the abatement notice we were served by Mr. Thomas Augustine of the Department of Environmental Health of the Cayman Islands. It concerned our jointly owned property - Block 105 Parcel 59. I was asking for her help in cleaning up the property, since the notice listed her name as well and she bore half the responsibility. Her emails back to me, in my opinion, were just ranting. I made copies of these emails, along with the abatement notice, and gave them to the officers signed and dated by me. I wanted them to sign my copies that they received them, but the officer whose name I don't know said that wouldn't be necessary. So I have attached them to this email as well. This is a very serious matter, as you know, since the Governor is involved. I want to make very sure the Governor gets all the facts, so I can show that there is no harassment involved in this complaint by Elsie, just a simple request to a joint land owner for help with a problem on our land. I was following the letter of the law.

I also want to mention to you a conversation I had with Officer Ferguson a few weeks ago concerning a posting on Facebook that was brought to my attention. (I have attached the copy of this.) It was to Elsie from her Nephew, who was referring to me as a con artist and even more disturbing - a "Motherfucker". I gave a copy of the posting to Officer Ferguson and his reply was "We need to keep the peace." (According to the law, this Facebook comment was a "breach of the peace". Mr. Owens - that is law). I left him with that, and haven't heard anything back regarding this issue.

This whole situation with Elsie is very unfortunate, and leads me to ask - "What are MY rights?" I hold citizenship in three countries - Great Britain, the United States and the Cayman Islands - and should be protected under three different constitutions. These two officers came all the way into my yard today when the gate was closed and only stopped at the bottom of the steps when they noticed Diane and me on the deck. I have a gate for a reason, and it should be respected. I know I'm hard to reach on the phone due to my health issues, but Diane has a phone she listens to, and she checks my email address and her email address on a regular basis throughout the day. In the future, perhaps that can be mentioned to your officers. I would appreciate if they could call or email first and leave a message. I will get back with them as quickly as possible.
