Mr. Owens,

I had to take a couple days to think about your brief emailed response before I could reply. First, let me address the issue you touched on in your reply, and then I want to address everything that, in my opinion, you left out.

You were "aware of a report" Mrs. Kynes made to the police regarding communication between the two of us. Apparently Mrs. Kynes "is requiring" that we both communicate via our "attorneys". I find this exceptionally odd, since, unless she just recently hired another one, she doesn't have an attorney. Mrs. Bing Thompson was her attorney, but she appeared before a judge last October 24 to come off the record and not represent Elsie any longer. She had to get a court date and appear before a judge because Elsie ignored the document that Mrs. Thompson provided her a few months prior on August 13. This document was called "notice of acting in person", and all Elsie had to do was sign and return it. When that didn't happen, a court date had to be set, and more time went by, and all of that caused the final hearing to be delayed until February 18 of this year. This delay was very costly to me, since I've had an attorney for the entire 3 years this divorce has been dragging on. I pay my attorney \$500 per hour. And I'm certainly not going to use him to communicate a simple request to Elsie to help me clean up jointly held property.

I think that addresses your brief comment. Now let me address everything you left out. To make it easier, let me provide a summary with bullet points:

- The tall officer (whose name I don't know yet) stated Elsie's complaint went to the Governor. He stated this twice, in a very firm manner. You don't mention the Governor. Why?
- The two officers did not provide me with any documentation of this complaint, although the tall one was holding some paperwork in his hand. Why?
- I provided them ample documentation to explain that, in my opinion, I had not been harassing her, but simply emailing her and asking her for help to clean up our jointly held property that was just served with an Abatement Notice. This notice had her name listed on it as well, and I gave the officers copies of all of this. I also showed them a copy of the CNS news story about the protest in front of this property, that stated Elsie showed up to join the protest. As joint owner, she allowed the protesters on the property. I asked the officers to sign they received it all - a simple request. The tall officer refused. Why?
- I included a paragraph in my email about a Facebook post by Elsie's nephew where he called me a "son artist" and a "Motherfucker". I explained I had turned this over to Officer Ferguson months ago and heard nothing. You left out any mention of this. Why?
- I asked you - nicely - if you could please tell your officers to respect my privacy and when the gate is closed please keep out of my property. The gate nicely states "Not Now" instead of

"Keep Out" but it's still clear that I don't want to be disturbed. I can be reached via email or phone. You never acknowledged this heartfelt request. Why?

Mr. Owens, I truly have reached the end of my rope. This incident with the officers coming onto my property unannounced and the tall officer literally getting into my face in an overly firm manner and accusing me of harassment was the final straw. I remained calm and told them I had documentation to defend myself and negate this claim of harassment, and the tall one actually said he didn't need to see that or hear what I had to say! I had to point out what it says on his vehicle "to serve and protect" and it was time for him to serve and protect ME. He backed down after that.

When this divorce started in June 2011, I received a phone call from Officer Ferguson who demanded my promise that I would cause no trouble. I couldn't hear him on the phone, and so immediately drove to the police station since it was a serious issue. He said that Elsie had called him and complained that I was going to cause trouble. I'm sure you have a record of that complaint with the date and time and resolution, signed and documented by Officer Ferguson. I told him my only promise was that I would not be the cause of any trouble, but I couldn't speak for her. But I remembered my promise and have abided by it.

This was why I didn't call the police with a harassment complaint when Elsie began stalking me and taking pictures of me in the past few months. She drove by where I was working on a friend's house and took pictures of me. Sometimes she would stop and hide in the bushes and take pictures. If I were at our other property where I'm creating my art, she would drive back and forth and take pictures. Sometimes she would see me riding my bicycle and follow me slowly and take pictures. I would often see her slowly driving by the house where I live, back and forth and back and forth. Even though her name is still on both of these properties, this was a clear case of stalking and harassment in my opinion, but I chose to ignore it and not file a complaint. I have attached some of the pictures she took and sent to my attorney. At one point, I even took my shirt off to show her how ill I am. I couldn't believe she still took a picture of that and sent it to my attorney. I have instructed him to please ignore all emails from her and forward them to me, which he does without charging me. And he receives many emails from her, most that make no sense, in my opinion. I was also told she was posting these pictures on her Facebook page.

Hopelully this email will explain my frustration and why I've reached the end of my rope. Where are my rights? Because I'm that "crazy, controversial artist" who apparently is a "heather" and "worships the devil" then its acceptable for police officers to invade my privacy and come onto my land, get into my face and demand that I immediately stop harassing my estranged wife or "face prosecution"? And be told - twice - they were there "on behalf of a complaint to the Governor", but then not be shown any proof of this by the officers? And after emailing my concern to the Chief Inspector, still not receive confirmation that - as his officer stated - the Governor is involved?

Again, Mr. Owens, where are my rights?

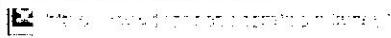

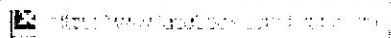
