Subject: My meeting with you on September 9, 2014

Mr. Ferguson,

On Tuesday, September 9, 2014, I came into the police station to file a formal complaint. You were the police officer on duty at the time to assist me. I brought in documentation to substantiate my complaint, and had extra copies to leave with you. The documents were Facebook postings from my ex-wife Elsie Kynes, her nephew Sean Smith, and Kimberley and Dalkeith Ebanks. Among other things, these people called me "the king of the shit pots, a con artist, a motherfucker, and they also said I build crap". Aside from the fact that these are an attack on my personal character, I own a construction company on Cayman Brac that is my only source of income, and these comments were also an attack on that.

As I presented my case, you appeared to be agitated and bothered. You barely took the time to glance at one of the documents and then retorted "I don't see your name mentioned on this", and handed it back to me. I was a bit surprised at your rude behavior, but I went on to explain that my name IS mentioned, and that it was a clear cut case of breach of the peace, and I would like to press charges against the people concerned and prosecute them to the full extent of the law. I then very politely asked you to initial and date my copies and you refused.

At this point, you said "You have no breach of the peace here. You're wasting my time. I don't have time for this" and you literally turned your back on me and ignored me! I was shocked at how extremely unprofessional this was, but calmly stood up and walked out, telling you we'll deal with this at a later date.

Now Mr. Ferguson, I ask you, why did you feel your time was not being wasted when my ex-wife called the RCIP (or the governor, if that truly was the case), to complain about me? She had an <u>unsubstantiated</u> verbal complaint that I was harassing her, and you and another officer took the time to come into my yard through a <u>closed gate</u>, invade my privacy, and very rudely get into my face demanding that I leave my ex-wife alone. And then when I wanted to give you paperwork to prove I had NOT been harassing her, I was told by the other officer "I don't need to see anything from you".

The treatment of me that day, and now your treatment of me this past Tuesday, are both examples of discrimination by the Cayman Brac RCIP, and I've had enough. We have laws on these islands, and they apply to all the citizens. I deserve to be treated fairly and not brushed off by you in this manner.

Because you refused to accept my copies, I have attached them to this email. They clearly show my name mentioned. After your comment, I fully researched the term "breach of the peace" and concluded that is not the appropriate term. On further research, I discovered the appropriate terms are "slander" and "defamation". Here is a legal definition and comments about each term:

Slander

Oral defamation, in which someone tells one or more persons an untruth about another, which untruth will harm the reputation of the person defamed. Slander is a civil wrong (tort) and can be the basis for a lawsuit. Damages (payoff forworth) for slander may be limited to actual (special) damages unless there is malicious intent, since such damages are usually difficult to specify and harder to prove. Some statements such as untrue accusation of having committed a crime, having a loathsome disease, or being unable to perform one's occupation, are treated as slander per se since the harm and malice are obvious, and therefore usually result in general and even punitive damage recovery by the person harmed.

Defamation

Any intentional false communication, either written or spoken, that harms a person's reputation; decreases the respect, regard, or confidence in which a person is held; or induces disparaging, hostile or disagreeable opinions or feelings against a person.

I have copied the appropriate people on this email and I expect this situation to be dealt with according to the law.
