Subject: Status on complaints made to RCIP

Mr. Owens,

You had asked last week in a previous email to clarify what I wanted investigated.

I have attached the email chain about one of the issues involving the slanderous comments made about me on Facebook by Kimberley and Dalkeith Ebanks and Elsie Kynes and Sean Smith. As you remember, I tried to file a report with Sgt. Ferguson

concerning this and was treated so rudely I reported the incident to David Baines - see the email chain below. Mr. Baines replied with the comment "a review of the material attached is required by someone other than Sgt Ferguson." You were off island at the time, and I requested you deal with it, and said I would wait. I'm still waiting. What is the status of this? As I told Sgt. Ferguson, I would like to prosecute these people under the full extent of the law.

Since that incident, another even MORE slanderous comment has been made in an email from my ex-wife. She actually stated that I "put a hit out on Gary Wong"! I had forwarded you that email on October 15 and asked for your advice on her remark. I never received a response.

I have the **proof** of this slander in writing, and when I try to bring it to the attention of the RCIP for help to defend my rights, I get ignored. However, all my ex-wife had to do was make a phone call and make an unsubstantiated VERBAL complaint against me, and two officers are sent to my yard to invade my privacy and get in my face in an extremely rude manner. Then I'm not even allowed to try to defend myself? Mr. Owens, how would you feel if this were happening to you or someone you loved? It feels like discrimination and harassment to me.

The last incident David Baines had asked you to look into was the status of the complaint I had made in 2009 about the burning of my Atlantis pyramid. On September 30 in an email Mr. Baines said, and I quote "I have asked Mr. Owens to review the crime report of the matter from 3 yrs. ago and update you as to what the investigations revealed or otherwise". I haven't heard anything from you. What is the status on this?
