Re: Permission to burn "The Apocalypse Now" sculpture

The Department of Environmental Health (DEH) acknowledges your email request regarding the above.

Approval is given for you to burn your art work, "The Apocalypse Now". However, this is a one-off approval for this event only. No other burning is allowed on the property in the future. Also, please be guided by the following:

1. The fire should not generate smoke in quantities as to cause a nuisance to the surrounding neighbours.
2. The fire shall be under strict control and supervision at all times.
3. After the event is completed, the fire must be completely extinguished. Under no circumstances should a fire remain kindled.
4. An adequate supply of water or other suitable substance/material should be readily accessible for fire control purposes. Preferably, suitable arrangements with the Fire Services Department.
5. No toxic or potentially toxic materials or products should form part of the fire.
6. All wastes generated must be collected and properly disposed of in a sanitary manner.
7. Persons should maintain a respectable distance from the fire in order to prevent injury.
8. Children should be monitored at all times.

I want to state clearly that the statements made above are false. Prior to your email of March 30th 2014, you have never asked me permission to burn and I have never given any permission in the past whether verbal or in writing. I have no authority to do so and it is for this reason I referred you to the Director. As a matter of fact I was totally unaware of any burning which you admit undertaking until your email of March 30th 2014. If you burned on that property before, you did so without any permission.

Mr. Carter,

Mr. Augustine has referred me to you to obtain permission to burn on my property on the south side of Cayman Brac. I must say, this puzzled me a bit, since in the past I've dealt directly with Mr. Augustine with these permissions and there's never been a problem. Actually, I had burned on this same piece of property on more than one occasion in the past, and all it took was a phone call to Mr. Augustine to explain where I wanted to burn and when. (You can still see the remains of this burning.) He always gave me verbal approval, and never even asked what I was burning. So I'm sure you can understand my confusion. Apparently, the rules have changed on how to get permission for a burning.

As I'm sure you're aware, I've created a sculpture called "Apocalypse Now", and this is what I would like to burn, and it represents the Battle of Armageddon. As I explained to Mr. Augustine in my email I've included below, I will be photographing and creating a video of the burn and I have people standing by to do this. I also explained how the structure was created with this burning in mind. The fire will be contained inside the mound, with the top designed to release the heat and smoke and some fire. Most of the burning will be internal, and this will cause the mound to collapse into a heap of rubble as this happens.

In addition to this explanation of the built-in safety features in the sculpture, here are additional items I propose to insure the safety of the burning:

1. A fire truck will be standing by just in case – I've cleared this with Mr. Whitney Tatum, the Fire Chief on Cayman Brac.
2. Weather conditions will have to be right – I'll wait until they are.
3. If more information is needed, I'll meet a member of the DOEH at the site personally.
4. I will speak to Chief Inspector Frank Owens about assisting with traffic if needed.
5. After the burning and my filming are complete, I'll have the fire department extinguish the remains just to be 100% sure there are no remaining embers.
6. The following day, Scott Development will remove the remains.

After this burning, I will continue my trilogy.

Repairs will have to be made to the sculpture from vandalism before I do this burn, and as I said, I'll wait for the right weather conditions. But I would like to obtain your permission immediately so when the weather is right and I've arranged all of the above, I can make it happen.

I hope this is sufficient information for you to understand this will be a very safe, well-monitored burn and will cause absolutely no harm to the surrounding environment.
